# **OER Steering Committee (2019-2020)**

#### Definition

Open educational resources (OER) are teaching, learning, and research materials in any medium—digital or otherwise—that reside in the public domain or have been released under an open license that permits no-cost access, use, adaptation, and redistribution by others with no or limited restrictions (Hewlett Foundation, 2018).

#### Introduction

The Bureau of Labor Statistics calculates that textbook costs have increased four times the rate of inflation in the past decade.<sup>1</sup> Students in the U.S. spend \$14 billion yearly on college textbooks and Federal student aid accounts for \$3 billion of that spending<sup>2</sup>. Though textbooks are not the most significant college cost, they are the largest out-of-pocket expense aside from tuition that students encounter each year.<sup>3</sup> To manage college costs many students do not purchase or rent course materials which results in less learning and/or enrollment in fewer classes, slowing progress to degree completion.<sup>4</sup> The growing body of research shows that 93% of students who use OER do as well or better than students using traditional publisher materials.<sup>5</sup>

In fiscal year 2017, College of DuPage students spent over 5.5 million dollars on textbooks in our college bookstore. The average full time student taking a general education transfer curriculum at COD could spend between \$463.00-\$900.00 on required textbooks per semester, if they purchase or rent the material at all. The U.S. Student PIRGs found that by switching just 10 introductory general education courses to OER could save students in the U.S. more than 1.5 billion dollars per year. COD students could also benefit from these savings through our own OER program. The use of free and low-cost course materials could be an effective strategy to alleviate financial burdens on students, increase access to education, improve student success, and would incentivize enrollment. A committee of knowledgeable employees should explore the potential benefits of OER and respond to College leadership with recommendations for moving the College forward in the important task of making college more affordable for students in District 502.

- Develop training and other types of outreach to educate the college community about OER.
- Explore grant opportunities such as the Open Stax Institutional Partners program.

- Research an OER incentive plan for COD faculty.
- Assist students in their understanding of open educational resources and college affordability.
- Develop potential research designs and data gathering plans to study the effectiveness/efficacy of OER at COD.
- Explore the feasibility of incorporating OER into the guided pathways initiative via a ZTC (zero text cost) degree pathway.

## Meetings

The committee will meet in person once monthly and meet as needed weekly online.

## Reporting

The committee will keep detailed minutes of meetings and provide monthly summary reports to be shared with the Provost's office and the college community via the Portal.

The committee's research findings will be compiled in a report with specific recommendations to be submitted to the Provost & College President.

At the direction of the Provost, committee members will present to the BOT Academic Committee and/or the Committee of the Whole.
